# School Description and Mission Statement

Taft Middle School has served the Serra Mesa community since 1961. The community is an ethnically diverse mix including many professionals, military families, and retirees.

The student population at Taft mirrors the demographics of San Diego. Approximately 66 percent of our student population resides in the Serra Mesa community, while 20 percent comes to us from the City Heights community through the Voluntary Enrollment Exchange Program (VEEP). Many students also choose to attend Taft through the School Choice program.

Taft is a comprehensive neighborhood middle school (grades 6 through 8) that offers a Gifted and Talented Education (GATE), foreign language (Spanish), instrumental music, art, advanced common core math classes, as well as technology and engineering elective classes. We also have a Special Education programs designed for most levels of students with IEPs. The PrimeTime before and after-school program offers many more extracurricular activities and academic tutoring.

The mission of Taft Middle School is for all children to achieve academic excellence in a safe and nurturing environment. In collaboration with families and the community, we will prepare each student to be a confident, contributing, highly productive and responsible citizen in a global society. All Taft students will graduate with the skills, motivation, curiosity, and resilience to succeed in their choice of post-high-school education and career in order be productive participants in this global society.

# School Facility Conditions and Planned Improvements (2015–16)

Our clean and well maintained site helps to create a welcoming atmosphere for everyone involved in educating our students. We have a well organized campus with well maintained classrooms and several conference rooms for meetings and our weekly staff development sessions. Thanks to our excellent custodial crew, the classrooms and the main campus are cleaned and maintained daily. A scheduled maintenance program is administered by the district to ensure the maintenance of classrooms, facilities, and landscaping.

Since its opening in the 1961–62 school year, Taft Middle school has been well maintained and has undergone various improvements. In November 2014 conversion from analogue to digital telephone and internet was completed. Most recently, in the summer of 2014, the district painted all of our buildings in a fresh, new color.

Plans for whole-site modernization are currently under way with the funding from Proposition S. Construction is scheduled to start in January 2016 and will include new pedestrian and vehicular access for drop-off and pick-up, security lighting, renovation of the food service areas, repair and upgrade of electrical systems, improvement of building interiors and exteriors, plumbing and sewer lines, and sidewalks and walkway areas. Additional renovations will include IDEA improvements to all restrooms and public areas to allow access to people with physical disabilities.

#### Statewide Assessments

#### CAASPP Assessment Results

The California Assessment of Student Performance and Progress (CAASPP) tests students in English language arts/literacy and mathematics in grades 3 through 8 and grade 11. The CAASPP was piloted in 2013–14 and first administered statewide in 2014–15. CAASPP scores are ranked according to four "performance levels": Level 1 indicates that the student has not met the standard tested; Level 2 indicates that the student has nearly met the standard; Level 3 indicates that the student has met the standard; Level 4 indicates that the student has exceeded the standard. Students scoring at Levels 3 and 4 have met state standards in that content area.

**Note:** In the tables that follow the number of students tested includes students who did not receive a score; however, achievement-level percentages have been calculated using only those students who did receive scores.

#### Career Technical Education Programs (2014-15)

Career Technical Education (CTE) in the San Diego Unified School District is a program of study involving a sequence of courses that integrates core academic knowledge with technical skills. The program provides students with multiple pathways to college and careers. Students complete a career pathway, which includes: (a) two or more CTE courses in a single, defined field of study, (b) passing of the pre-and co-requisites CTE and core curriculum courses, and (c) passing of at least one CTE advanced-level course. The career pathways are organized within the context of the state-defined 15 different industry sectors, which have been identified as critical for the fiscal stability and prosperity of the State of California. Student internships are a required component of the advanced-level CTE course curriculum. CTE programs of study often fulfill the "a–g" subject-area requirements of the University of California and the California State University and may lead to community college credit, an industry-recognized credential, a certificate, or a degree at the postsecondary level.

#### Courses for University of California and/or California State University Admission

#### University of California

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well as those transfer students who have successfully completed specified college work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for university-level work. #### California State University

Admission requirements for the California State University (CSU) include three factors to determine eligibility: specific high school courses; grades in specified courses and test scores; and graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. #### School Safety Plan (2015–16)

Campus safety is the district's top priority. Principals, teachers, support staff, school police services, and community organizations work together to prevent, prepare, and respond to emergency situations. To ensure safety and security, each school has a state-mandated individual emergency response plan that is updated annually and posted on the school's website. School staff members participate in regular emergency-preparedness drills and response training. Substance abuse prevention programs are presented to students regularly. Policies and procedures are in place to address safe entry and exit of students; serious disciplinary problems; discrimination, harassment and bullying; mandated child abuse reporting procedures; and school dress codes.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

The safety of all children is paramount to the staff and community. All visitors are required to sign in at the front office and obtain a visitor's ID badge. Closed-circuit video cameras are strategically placed throughout campus in order to monitor activity and to ensure safety on campus. With whole-site modernization, which began in the 2015–16 school year, the number of video cameras will be increased and fencing added to completely secure the campus.

In order to maintain a safe and secure learning environment, the staff, administration, and Site Governance Team have embraced the Positive Behavior Interventions and Supports (PBIS) program. The program encourages a positive approach to curtailing negative student behaviors. All students know about the "Eagles' Way" attributes and are reinforced with rewards when they are caught following those attributes. The PBIS committee's contributions have had a tremendous impact on student behavior, and discipline issues continue to decrease. In addition, students are taught about and expected to know the district's zero-tolerance policy with regard to physical violence and bullying.

In addition, we are beginning to implement strategies from the International Institute for Restorative Practices. Through these strategies teachers are building more positive relationships with students. When students find themselves stuck in a pattern of behavior that they don't know how to change, our job is to teach them and help them to make those changes.

Taft's proactive approach to student discipline has improved the overall climate of the school and, in turn, has contributed greatly to the general safety of our students.

#### Professional Development

The district and the Board of Education have set a high priority on professional development, with the goal of providing targeted professional development to build capacity and knowledge to support student learning success. The Office of Leadership and Learning collaborates with other departments to provide teachers and administrators with ongoing professional development, including improving teaching and learning related to the Common Core State Standards, educational technology, advanced studies, and leadership development. Sessions offered at various times throughout the year focus on a wide variety of professional development aimed at strengthening content knowledge to meet the needs of all learners, with an emphasis on targeting the needs of our English language learners, students with disabilities, and other struggling learners.

In addition to district-provided professional development, principals identify a schoolwide focus each year for professional development and also determine areas of individual need. Throughout the year, teachers participate in school-based professional learning communities (PLCs) to encourage best practices and shared problem solving. Teachers are provided with useful data systems that allow them to improve the learning of each student. Principals also provide the ongoing training needed to be professional site managers. Staff release for professional development is organized in a variety of ways on a site-by-site basis throughout the year.

Our teachers plan and design professional development around "best practices." Teachers have the opportunity to participate in various professional development activities on and off campus.
